Please take notice that the City Council of the City of Fenton will hold a public meeting at 7:30 p.m., on Monday, October 26, 2020 by convening the City Council through remote electronic access as provided in this Notice. Electronic remote access will be implemented in response to COVID-19.

The Council is meeting to authorize payments of invoices and file meeting minutes, to discuss approving Resolution No. 20-34 to vacate a portion of Ellen Street, to discuss approving Resolution No. 20-25 to exclude city employees hired after June 30, 2018 from being eligible for healthcare coverage or subsidy payments, to discuss PA 202 Corrective Action Plan to file with the State of Michigan, and to cast the ballot for the nominees for the MML Liability & Property Pool Board of Directors, and to conduct any other basic operations presented to the Council.
