**VI. Homeowner Affidavit**

**VII. Fee Clarification**

Item #2, Residential Heating System: This item is used for the installation of a heating system in a new residential structure. Item #11 Gas piping and #18 Duct SHOULD NOT BE charged. Replacement Systems should be itemized.

Items #15 & #17, Tanks: A homeowner must own tank to install. If homeowner does not own tank, a licensed mechanical contractor must install tank.

**IX. Instructions for Completing Application**

**General:** Mechanical work shall not be started until the application for permit has been filed with the City of Fenton. All installations shall be in conformance with the Michigan Mechanical Code. No work shall be concealed until it has been inspected. Contact the City of Fenton at 810-629-2261 to schedule an inspection, giving a minimum of 24 hours notice. Job location, condition of access and contact phone number is required for inspection.

**Expiration of Permit:** A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED OR REINSTATED.

**Where to Submit Application:** The City of Fenton is responsible for electrical code enforcement within the municipal limits. Permit applications may be sent to the attention of the City of Fenton Building/Zoning Department at 301 S. Leroy Street, Fenton, Michigan 48430.
